Raw materials, goods and substances:	Co extruded PA/PE (internal side film)
Purpose:	For food packaging
General characteristic:	<p>Can be used for packaging of all type of foodstuff, i.e. for meat and meat products, cheese, fruits, vegetables, confectionary products, etc. Can touch food all its surface.</p> <p>This product should be placed in a clean, cool and dry place. Bag storage conditions: 10-25°C. Protect from direct sunlight. Cannot come into contact with chemicals that are harmful to the body. This product must maintain the shortest distance - 1 meter from the source of heat.</p>
Chemical testing:	<p>Migrants does not exceed the maximum allowable limit, and the levels of materials and articles intended to come into contact with food and meets specially health safety requirement; the materials and products meets specific health safety requirement.</p> <p>Samples were tested into the contact with food covered by ethanol 10%, acetic acid 3% and vegetable oil for any long term storage at room temperature or below, including heating up to 70°C for up to 2 hours, or heating up to 100°C for up to 15 minutes. To come into with food covered by ethanol 10%, acetic acid 3% and vegetable oil for high temperatures applications at temperature up to 100°C.</p>

Usage conditions:

Embossed bags complies to Reg. UE 10/2011 and following edits for use at temperatures between 80°C for 24 hours and -20°C for unlimited time.

Heavy metal testing:

Lead, cadmium, mercury and chromium (Pb, Cd, HG, Cr) level in the products does not exceed the maximum allowable limit.
